This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

### **What is the Product?**

#### **Type**

English law governed over-the-counter (OTC) equity derivative transaction linked to the worst performing share among those set out below with 'autocall' and 'memory coupon' features. Forms of contract documentation governing this type of transactions can be found at: <https://ultimaproducts.hk>. You may invest not less than USD 80000.0 in the product.

Under the applicable laws and regulations of the relevant jurisdictions, including Hong Kong, the Republic of Cyprus or the DIFC, it may be required for you to enter into OTC derivative transactions with The Ultima Products HK Limited through a duly authorized and regulated investment firms (including The Ultima World (DIFC) Limited) acting as agent for and on your behalf (intermediary). The Ultima Products HK Limited does not guarantee that any intermediary will agree to act for and on your behalf in entering into any such transactions.

You are hereby notified that the product issuer and its counterparties belong to the same financial group.

#### **Objective**

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) a cash payment depending on the **worst performing share** current price as of Redemption Valuation Date (as defined below) on termination of the product. The timing and amount of these payments will depend on the performance of the underlying shares. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If, at redemption valuation date, the at least 1 of the worst performing share's **current price** (as defined below) has fallen below the Redemption price, you will receive the worst performing share in its **volume** (as defined below) and, consequently, **LOSE UP TO YOUR ENTIRE INVESTMENT**.

**Coupon.** If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* Coupon Barrier Price 3 of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to coupon rate 3 on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupons at Coupon Rate 3 for the previous period(s) multiplied by Snowball Coefficient (if no coupon rates were paid on the previous periods).

If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* Coupon Barrier Price 2 of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to coupon rate 2 on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupons at Coupon Rates 2 for the previous period(s) multiplied by Snowball Coefficient (if no coupon rates were paid on the previous periods).

If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* Coupon Barrier Price 1 of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to coupon rate 1 on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupon rates 1 for the previous period(s) (if no coupon rates were paid on the previous periods).

If no Coupon was paid regarding the condition above and at least 3 underlyings' Current price is equal or above respective Star-effect Coupon Price for the particular Event Determination Date the Buyer will receive:

- (a) Coupon equal to the Coupon Rate 1 on the Notional; and
- (b) Coupons calculated with respect to all preceding Coupon Periods, for which no Coupon payments were made multiplied by Snowball Coefficient.

For the avoidance of doubt, if any terms set forth herein are not met no Coupon will be paid for the relevant Coupon Period. **Early termination following an autocall.** The product will terminate prior to the maturity date if:

(a) on any event determination date, the current price of the worst performing share *is at or above* Autocall price, stated for the particular **event determination date below** OR

(b) at least 5 underlyings' Current price is equal or above respective Star-effect Autocall Price for the particular Event Determination Date. In such case, you will, within two (2) business days following that event determination date, receive, in addition to any final coupon, a cash

payment equal to the amount of your investment, multiplied by the Autocall coefficient, stated for the particular **event determination date below**. No further payments will be made on any date after such event determination date.

**Termination on the maturity date.** If the product has not terminated early, on the maturity date, you will receive:

- (1) if the final reference level of the worst performing share is below 65.0 % of its initial price on the redemption valuation date and less than 3 underlyings' prices on the redemption valuation date is equal or above respective Star-effect Redemption Price, the Seller shall pay to the Buyer amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date or
- (2) in other case, a cash payment equal to the amount of your investment plus payment of amount multiplied by autocall coefficient (as defined below);

**Potential adjustment events.** If during the lifetime of the product a split, consolidation or any other event having a diluting or concentrative effect on the theoretical value of the relevant underlying share occurs the terms of the product may be correspondingly adjusted and you will be duly notified of such adjustment.

**Extraordinary events.** If during the term of the product any extraordinary event (such as nationalization, insolvency or delisting) occurs in respect of an issuer of any underlying share, such share's current price in respect of any date for the purposes of the product shall be decreased by 30%. Consequently, due to an extraordinary event you may **LOSE UP TO YOUR ENTIRE INVESTMENT**.

#### Definitions

<b>Autocall coefficient:</b>	The multiplier of notional for the additional payment in case of autocall
<b>Autocall price</b>	For each share, its initial price multiplied by autocall barrier
<b>Coupon Barrier Price N</b>	For each share its initial price multiplied by Coupon Barrier N
<b>Current price:</b>	The closing price of an underlying share as of an event determination date, redemption valuation date or early termination valuation date
<b>Volume:</b>	In respect of each share - the amount of your investment divided by product of Price Coefficient, and 100% of such share's initial price rounding down to the nearest whole number.
<b>Event determination dates:</b>	following the valuation date
<b>Initial price:</b>	The closing price of an underlying share as of the valuation date
<b>Price Coefficient</b>	The multiplier of the initial price for calculation of the Volume
<b>Redemption Valuation Date:</b>	24.03.2030

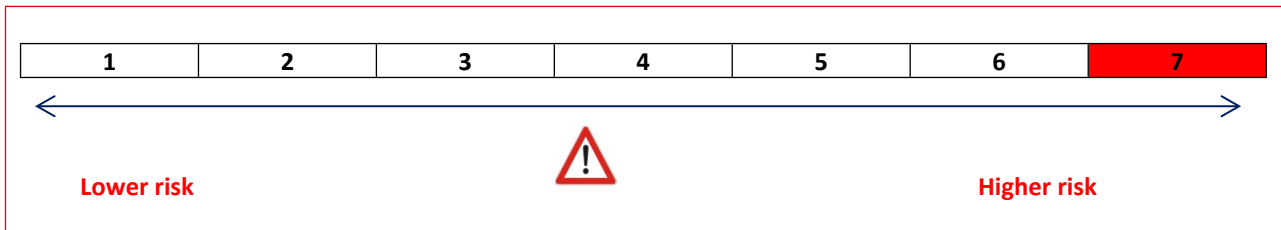
#### Intended retail investor

This product is intended to be offered to retail investors who fulfil all of the criteria below:

1. they have prior experience in investing in derivative products;
2. they can understand the interaction between the conditional payments under the product and the underlying shares' market performance;
3. they can afford to have their invested capital locked in for the full term of the product;
4. they can afford to lose part or all of the capital invested in the product;
5. they can understand the essence of extraordinary events, and comprehend the negative effect that such events can have on the product's financial result.

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements on the market or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class and rates the potential losses from product performance at a high level. This product does not include any protection from future market performance so you could lose some or all of your investment.

The Ultima Products HK Limited applies its own risk methodology to determine summary risk indicator as well as performance scenarios indicated in the product documentation (KID). This methodology whilst based on the Packaged Retail and Insurance-Based Investment Products (PRIIPs) requirements, does not fully follow the requirements of the PRIIPs regulatory framework under Regulation (EU) No 1286/2014 which serves merely as a guidance and as an example of best practice.

### What happens if The Ultima Products HK Limited is unable to pay out?

### What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest USD 10 000. The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. The total costs are composed of the **early termination cost** up to 35% of the amount you invest.

### **How long should I hold it and can I take money earlier?**

**Recommended holding period:** 48 months

The product aims to provide you with the return described under “What is this product?” above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the **early termination amount** equal to 65% of the Notional multiplied by the lesser of (a) one; or (b) the ratio between the Worst Performing Share’s Current Price as of Early Termination Valuation Date and 100% of its initial value. The The Ultima Products HK Limited may at its own discretion increase the Early Termination Amount.
