The manufacturer designed this product for a theoretical investor and suggests you liaise with the distributor to ascertain if you fit the criteria of its intended target market. You are aware that the underlying asset can include an Exchange Traded Funds/ Exchange Traded Trusts (ETF/ETT) with exposure to Crypto Tokens. Since the underlying assets are extremely volatile these ETF/ETT products are considered as high risk, the value of which can fall as quickly as it can rise. These products are complex and the associated risks may be hard to understand. You may lose, all or part, of their investment. Consequently, investing in and holding these products is not comparable to investing in traditional investments. The underlying Crypto Token ETF/ETT may not always be liquid or transferrable and may be vulnerable to cyber theft.

This investment may be right for you if:

- You understand that on **Upon expiration** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price** and its initial level and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price** and their initial level the previous missed coupons will be paid including any other coupon due

- **You understand that on Upon expiration basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the initial capital to you, including coupons and other payments that may be due**
